# AUCTIONEER OF THE YEAR

## ENTRY CRITERIA

- Nominations will be accepted from Institute members (as defined in the REI ACT Constitution) or employees of Institute members.
- Nominees must have conducted 85% of their business in the ACT for the period 1st January 2023 – 31st December 2023, with a minimum of 11 auctions conducted.
- Only Institute members (as defined in the REI ACT Constitution) and employees of Institute members will be eligible to represent the REI ACT at the 2024 REIA Australasian Auctioneering Championships to be held in Tasmania 14 – 16th May. Institute members and employees of Institute members must be available to attend the championships as a condition of entry.
- The two REI ACT representatives for the REIA Australasian Auctioneering Championships will be announced at the end of the competition day at Hotel Realm on 11th April 2024.
- Winner of the Auctioneer of the Year Award will be announced at the REI ACT Awards for Excellence Gala Dinner to be held on Saturday 31st August 2024 at Hotel Realm.
